Old Mexico Restaurant Now Open in Quincy

The Gadsden County Chamber of Commerce announced the grand opening of the Old Mexico restaurant at 6765 Ben Bostick Road in Quincy next to Piggly Wiggly. The Chamber and Old Mexico hosted a ribbon cutting ceremony on the morning of May 4 just before the restaurant officially opened for lunch. The restaurant will be open daily from 11:00 a.m. to 10:00 p.m.

"We're happy to introduce Old Mexico to Gadsden County," said Michelle Burdick, the vice president of membership for the Gadsden County Chamber of Commerce. "Its evening hours will give our residents a place to enjoy a sit-down meal, not only for lunch, but also on weeknights and throughout the weekend."

Old Mexico, a family owned and operated restaurant, offers a warm and inviting atmosphere to relax and dine by combining an artistic metalwork from Mexico with serapes blankets easily recognizable by their colorful striped weave. With stucco walls glazed in antique yellow, the green, terracotta and red shades throughout the interior give off a warm glow. The wood



furniture, much of it handcrafted from recycled cypress and pine, lends a rustic authenticity in creating an experience true to the Mexican heritage. Aged timbers and a tin roof over a row of booths give a sense of privacy to diners.

"We want people to feel welcome and be comfortable while eating good quality food," said the owner and manager, Hector Bautista.

A variety of lunch specials including burritos, enchiladas, taco salad and

quesadillas are available for only five dollars and a family of four can easily order dinner and beverages for less than thirty-five dollars. All meals are prepared fresh for each order. A selection of margaritas and Budweiser products is available through the full bar.

During the opening process, Bautista dealt with local vendors and openly expressed appreciation of Quincy businesses such as Stone's Home Center, A.C. Electric, Inc. and Sanford Plumbing Service along with the zoning officials. It is his intent to continue working with Gadsden County businesses and encourages them to contact him about their competitive products for the restaurant.

Bautista and his family fully own and operate a total of three Old Mexico restaurants in Florida, two in Panama City and one in Perry, as well as three additional locations in Georgia

and two more in Alabama. The family also shares ownership of over forty-five Old Mexico restaurants across the southeastern United States.

The company also uses the basic soldering class as a "train to hire" program, in which TeligentEMS pays for the training class and then hires the top-performing students from the class depending on how many openings they have. This investment in their employees creates a low job turnover and enables staff to advance in position while creating a strong morale within the company.

The manufacturer and their employees use their intense bond to partner together to help Gadsden County communities. They take part in numerous benefits and community events throughout the year. TeligentEMS is a hands-on participant in the Havana Kiwanis Golf Tournament that raises funds for youth camps and a Tallahassee Community College scholarship as well as the American Cancer Society's Havana Relay for Life paying tribute to cancer survivors raising awareness and assisting in fundraising activities.
